1. INTRODUCTION



The European Crystallographic Association, hereinafter referred to as ECA, is a scientific association having as objectives the advancement of crystallography in all its aspects, and to promote cooperation in crystallography between the countries of Europe, Africa and the Middle East. ECA is one of the five regional affiliates of the International Union of Crystallography (IUCr). Our sister affiliates are the American Crystallographic Association (ACA), the Latin American Crystallographic Association (LACA), the Asian Crystallographic Association (AsCA) and the African Crystallographic Association (AfCA).

Crystallographic Organizations from countries within the ECA geographic area can affiliate as ECA National Members. Individual and Corporate memberships are also admitted.

4. EXPLANATION

BALANCE:

The balance of the accounts of ABN AMRO (Savings and Giro) and ECA PAYPAL on April 1st, 2023 is € 62'447.32 and has increased to € 104'645.00 until March 31st, 2024 (defined financial accounting period), meaning that the financial period finished with a significant surplus. This is due to the surplus transfer and support from the ECM33 in Versailles, donations received for the initiative 'Women in Crystallography' during the IUCr Congress in 2023 in Melbourne, and the hosting of the RSC grant received by GIG-03 for the 'Inclusion and Diversity' actions taking place in 2024. In addition, as 2023 was the year of the IUCr Congress in Melbourne, no ECA prizes and travel grants were scheduled during this financial accounting period.

The given balance reflects the net amount available after credits and debits.

INCOME STATEMENT:

During this financial report period (April 1st, 2023 to March 31st, 2024), 207 individual, 31 national, and 41 corporate memberships have been received - some individual and corporate members paid for several years.

A donation related to a surplus of the ECM33 held in Versailles in 2022 has been received.

The initiative 'Women in Crystallography', taking place at the IUCr Congress in Melbourne, was very successful, receiving donations amounting to € 1'451.00. In addition, a RSC grant of € 5'758.64 was received by GIG-03 for a video contest related to 'Inclusion & Diversity'.
