1. INTRODUCTION



The European Crystallographic Association, hereinafter referred to as ECA, is a scientific association having as objectives the advancement of crystallography in all its aspects, and to promote cooperation in crystallography between the countries of Europe, Africa and the Middle East. ECA is one of the five regional affiliates of the International Union of Crystallography (IUCr). Our sister affiliates are the American Crystallographic Association (ACA), the Latin American Crystallographic Association (LACA), the Asian Crystallographic Association (AsCA) and the African Crystallographic Association (AfCA).

Crystallographic Organizations from countries within the ECA geographic area can affiliate as ECA National Members. Individual and Corporate memberships are also admitted.

4. EXPLANATION

BALANCE:

The balance of the accounts of ABN AMRO (Savings and Giro) and ECA PAYPAL on April 1st, 2024 was € 104'645.00 and has substantially increased to € **216'344.66** until March 31st, 2025 (defined financial accounting period).

The financial period finished with a significant surplus. This is mainly due to the transfer of the ECM surplus transfer from past European Crystallographic Meetings (ECMs), more specifically to the ECM-17 in Lisboa, Portugal (1997), the ECM-18 in Praha, Czech Republic (1998) and the ECM-26 in Darmstadt, Germany (2010). These ECMs generated a significant surplus, which was in the following constituting the Perutz-Bertaut fund, hosted transitionally at the 'Verein der Freunde der TU Darmstadt' until the 11th of November 2024. The transferred 95'000 Euros to the European Crystallographic Association (ECA) to a dedicated ABN Amro savings account has its purpose of supporting the PERUTZ and BERTAUT Prizes awarded at future European Crystallographic Meetings (ECMs). We would like to acknowledge our deepest recognition and gratefulness to the 'Verein der Freunde der TU Darmstadt', and especially Prof. Hartmut Fuess of the University of Darmstadt, transitionally hosting these ECA funds. Our deepest thanks to Prof. Udo Heinemann and Prof. Christian Lehmann and all involved colleagues for investigating with passion the ANBI status and the involved financial issues forward to the benefit of our European Crystallographic association.

An additional final financial support has been received from the ECM33 in Versailles. The initiative 'Women in Crystallography' was very successful during the ECM Congress in 2024 in Padova, and also support talented women in turn for travelling to crystallographic conferences. 9 talented women in crystallography were awarded. In 2024, the 'Sheldrick Prize' was created for supporting brilliant crystallographers. Here, € 3605 have been donated from the University of Göttingen to ECA, who composed the election committee and awarded the Prize at the ECM34 in Padova, Italy. The 'Perutz', 'Bertaut' and 'Lodovico' prizes have also been awarded at the ECM34.

ECA supported substantially a number of crystallographic conferences and schools (see the list below), and additionally also young scientists for travelling to the ECM34. This time, 12 young talented crystallographers were supported with travel grants.

INCOME STATEMENT:

During this financial report period (April 1st, 2024 to March 31st, 2025), membership fees have been received from 155 individual, 32 national (<https://ecanews.org/about-eca/membership/national-members>), and 21 corporate members (<https://ecanews.org/about-eca/membership/corporate-affiliate-members>). Since 1st of September 2024, the membership for regular members has been increased from € 10 to € 25, with a 5-years membership of € 100. For student and retired members, the membership fee of € 10 has been maintained.
